POTOCOPY OF THE CERTIFIED PEDIGREE OF THE DOG TO A MINIMUM OF THREE GENERATIONS, with an official registration number for each and every one of the fourteen immediate ancestors, issued by a recognized stud book or record (e.g. AKC/CKC). **PLEASE NOTE:** Breeder's pedigrees, or pedigrees purchased from pedigree services are not acceptable, and that in the case of The Kennel Club, England (EKC) it is their Export Pedigree (not their Certified Pedigree) that is required.

COPIES OF DOCUMENTS SUBMITTED MUST BE CLEARLY LEGIBLE WITHOUT ANY INKING OVER THE TYPING.
